Updates on voter suppression bills!

These bills make it HARDER to vote, we will support making voting easier.

Legislative Update (KB): Implicit Bias Training for Healthcare workers, Elder Abuse Legislation (Elder Abuse Task Force), Woman's Repro Healthcare.

Legislative Update (MM): Allocating Federal COVID-19 Support in the state budget (both Mari and Kyra voted no on all budgets because Rs are not allocating relief money in ways Ds support), Affordable Housing Legislative Packages, Distributed Solar Power Generation,

### **Second Guest Speaker – Citizens Climate Lobby: Analia Honkanen & Matt Leese**

CCL is a nonpartisan organization that is designed to train grassroots organizers in communities across the country. The organization gives these organizers the knowledge and skills they need to volunteer and participate in educating their community about climate crisis solutions.

The specific approach that CCL is supporting is a bipartisan bill currently sitting before the US. Congress: The Energy Innovation Act. This is a fee and dividend strategy for carbon. The fee applies pressure on the supply side of emission producing economic actors and the dividend

pays that fee back to taxpayers (the government does not keep any of the fee). This approach both incentivizes economic actors and provides direct financial relief to taxpayers.
